



REPORTS:

PRESIDENTS REPORT:

Steve thanked council for all their hard work over the last year. He thanked Steve and Robyn Snelgar for hosting the council f2f meetings, saving the society quite a lot of money. He thanked Carol (his wife) for taking over the Herd registrar position. This has taken a lot of pressure off the society and she has done an excellent job in processing registrations and transfers.

TREASURERS REPORT:

Grant gave an in-depth explanation of the Treasurers report.

He talked about the time of year that members renew their subs in relationship to income at the time of writing his report.

The reprint of the Breeders Handbook was a large expense but a one of and we should have enough to last for some time.

Members that do not renew their subs by November will not receive a Dispatch and this will also save quite a bit of money

Grant commended Carol for clearing up the back log of registrations and transfers and noted what a difference this has made to the members.

The final stages of the Herd Registry upgrade has been completed to date with \$600.00 left, for any final adjustments, of the \$10,000.00 approved at the Gisborne AGM.

The Herd Book is now available online at www.dexter-cattle.co.nz (the society website). Printing paper herd books was becoming quite costly.

The budget has a couple of alterations due to timing – AGM date versus the date of writing the budget

The Herd Registry upgrade depleted the society funds and interest rates have dropped so interest earned is less.

Grant asked if there are any advertising claims still to come in for the National Open Day. There are still a bit to sort out in this area.

This year the AGM booklet was online rather than hard copies posted. Saving around \$800.00.

There is no Open Day next year and having the Herd Registry now complete will see extra funds in the society bank account next year.

We still have merchandise for sale that we are trying to clear.

Heather Cunningham queried the amount in the savings account and Grant explained this is often due to the time of year and income at that time.

AREA GROUPS:

Garth Woodward asked for any feedback on area groups. He also explained to members his health issues and looks forward to a more productive and positive coming year.

SHOWING AND JUDGING:

Betsy Smith briefly went over her report.

Margaret Perry talked about the steer class at the breed show. She felt it was important to show a good example of a meat animal.

Various members passed comments and what different shows have.

Tyna Charles said that at Christchurch has a butchers competition but it is not part of the actual showing and judging section.

Betsy explained that we must run our shows in accordance with the RAS & DCSNZ rules.

There has been a bit of confusion over steer classes

Individual A&P shows are able to have a steer class if they choose. They have their own rules and members would need to consult with shows to have classes added.

Mary Howard felt that eliminating steers is restricting the amount of members that are able to exhibit at shows.

Betsy Smith explained that individual shows are able to have other classes if they choose but steers and grades are not eligible to go into the Champion competition.

Royal shows do not allow steers or grade animals.

Betsy also explained that there had been very few steers at shows over the last year and so she took that as good indicator and is the reason steer classes have been removed.

At our Breed Shows we are able to add classes to suit our society.

Betsy explained the members need to go to their local A&P show meetings and have their say at a local level.

Angela & Richard Stevens felt that Canterbury was not a good show for Dexters.

There were discussions on cattle not of whole colour being shown. She explained the difficulty to police members that do not adhere to the breed standard.

Carol Ring said that more members are registering their Dexters later now that that they can be done up to 2 years old so this should assist when cattle go through colour changes at a young age. Members are being more particular about what they register

Snowline Trophy and Turoa Youth Trophy.

The SNOWLINE TROPHY was won by GPC Stud, Penny & Gareth Copsey with 33 points . They were not at the AGM.

Betsy went over the origin, history and criteria for the Snowline Trophy.

Turoa Youth Trophy was won by Arjen Pederson with 250 points.

Keith Wratt talked about the trophy and its origin as he and his wife donated the trophy.

THAT the Showing & Judging report as published on the website and in the AGM Booklet be accepted..

PROMOTIONS:

Betsy Smith and Garth Woodward have been sharing this role over the last 12 months.

Marti Winn said some X farmers came to their stud and said to thank the organizers for arranging a National Open Day.
Carol Ring suggested that we look at some new merchandise. Christmas cards, wall planners, calendars, re-useable shopping bags were suggested.

WEBSITE:

Grant Keymer did an on screen presentation of the website and the new herd registry.
In-depth pedigrees are now available and photos can also be included.
There are many search combinations available.
Searches can be done by any combination of the following – stud, owner, breeder, colour, grade, area, Sire, horns, animal name etc.
The data on the website is current to within a couple of days.
There is a hypothetical mating sheet available. Date of birth can be calculated according to mating date. Sire and dam details can be entered to show the hypothetical pedigree from a mating.
There are various options available online to members through the ‘member’s area.’
This is not available to the public and you must be logged on to access it.
Member details can also be researched online.
All cattle can now be registered online. A trial was carried out on females only and it has now been rolled out to all animals. Dna profiles must be done prior to registering bulls online.
Potential issues with possible Bull certificates were also discussed.
Robyn Snelgar thanked Grant for the huge job and the hours taken to set up the new register and what an asset it is to the society to have someone with his expertise on council.

RESEARCH AND DEVELOPMENT:

Di Burgess informed the members that this is the end of her term on council and wished council all the best.

Remit 4

THAT the complaints process be amended to the following -

3. MISCONDUCT OF MEMBERS– Complaints Procedures

A complaint may be made against any Member who refuses to abide by the requirements of the Constitution, Regulations, or Code of Ethics of the Society, or whose actions are considered prejudicial to the Society’s Objects.

- (a) Any person or organisation may make a complaint to the Council that the conduct of a member of the Society is or has been injurious to the character of the Society. Every such complaint must be in writing and will only be accepted as an official complaint if delivered to the Secretary within 90 days of the alleged incident.
- (b) If a complaint is made against the current secretary the complaint will be lodged with the president in the first instance.
- (c) If a complaint is made against any other council member, that member will be excluded from any discussion pertaining to this matter.

- (d) The secretary will advise council of any such complaint and decide if any further action needs to be taken.
- (e) If council is able to assist in a resolution all practicable steps will be taken to do so.
- (f) If necessary Council will refer the matter to the Complaints Officer(s) to investigate who will report their recommendations back to the secretary within 30 days.
- (g) The secretary will communicate the recommendations to council.
- (h) Council will consider the complaints officers report and will then proceed at their discretion with a final decision which will be binding on all parties and may include suspension or cancellation of offending party's membership.
- (i) If this complaint becomes a dispute it will be dealt with as a Dispute in accordance with the Constitution.

A member expelled by the Council may within thirty (30) days give written notice of appeal to the Secretary. The Secretary will then call a Special General Meeting to take place within sixty (60) days of receipt of the notice of appeal. If the decision of Council is upheld there will be no further right of appeal but if that meeting passes a resolution rescinding the expulsion, the member will be reinstated immediately.

Rationale - To ensure future complaints are handled according to due process in a fair and impartial manner. Proposed by council.

Remit 5

THAT the following be added to the transfer process of the regulations –

In the event of a non-member selling previously registered Dexters to a DCSNZ full paid ,member , these cattle are able to be transferred to that person with all the original rights of registered Dexters. The cattle will be inspected to confirm their identity by sighting at least 1 but preferable both ID tags registered with the DCSNZ – Nait tag and/or DCSNZ brass tag. To be confirmed by photograph.

Any registration forms to be returned to Herd Registrar, along with payment for transfer.

Any calves born whilst cow in non-member ownership cannot be registered. Any cow/heifer purchased in-calf, proof will be required that the sire is a registered Dexter bull and is owned by a current financial member of DCSNZ..

Rationale – This would set out clear guidelines for the Herd Registrar when handling these transfer situations.

Remit 6

THAT Regulations 7.2 (a) & 7.3(b) be updated to meet the requirements of the online Registration and Herd book systems to the following -

7.2 Prefix (Stud Name) –

- (a) All members of the Society who wish to breed and register Dexter cattle are required to register a unique name as a Prefix. The Prefix may be up to 15 characters in length (including spaces).

7.3 Animal Name:

- (a) Each animal must be identified by a unique given name commencing with and including the Prefix. Duplications of the spelling and pronunciation of the given name will not be accepted.
- (b) The animal's full name including the Prefix shall not exceed 35 characters in length (including spaces).

Rationale – This is a house keeping requirement needed for the new system to function correctly and effectively.

Note – The only change to the current regulation is the number of characters allowed.

Proposed by council.

GENERAL BUSINESS:

There were discussions on chondrodysplasia. Lindsay Tatton talked about her concerns with this. She felt that there are a lot of new members that did not have enough information about this condition. She felt that there needed to be more information made available to members on how to manage this condition.

Robyn Snelgar informed Lindsay and the meeting that since testing became available there have not been that many reported cases of bull dog calves. Also that there are members that breed carrier to carrier intentionally as they like the smallest Dexter's and are prepared to take the risk to breed the type of Dexter's they prefer.

Members breeding choices and/or the outcomes of these is not council responsibility. However it was acknowledged that members do need to be informed.

Marion Corbett talked about her concerns with cattle temperament. There have been reports of disillusioned new members that have purchased Dexters from existing members that have been very bad tempered. It is disappointing to see this happening rather than unruly Dexters being culled. Often these are bought unseen. It is noted that it is recommended that cattle are viewed prior to purchase to make individual assessment of temperaments.

Betsy Smith - G2 Registration
Richard Stevens – Show venues

South Island Breed Show
South Island members informed the meeting that Christchurch was not a good choice of venue for a breed show. It is a 3 day event and held from Wednesday – Friday. Because of this it was believed that there would be very few entries (if any) for this show

North Island Breed Show
Bruce Jones said that Council wouldn't let it be held in the Manawatu. Betsy gave a brief resume of the proposal the Jones' had put forward. They had been asked to submit a revised proposal to Council, but had never done so. There was no further discussion on this. Betsy explained the reasoning behind the NIBS being held elsewhere for the next 2 years ie the Royal Show is being hosted by the Manawatu Consortium. It was suggested that the NIBS be held in the Manawatu the following season ie 2015/16

National Open Day
We talk about the National Day and how we should do it in the future. Marion Corbett talked about council advertising in the major rural papers like Farmers Weekly. It was queried how many actually read this paper. Area reps could advertise in their own local media.

Vice President's Report

Richard's position was not filled as Council still had a quorum. Hopefully there have been nominations from the membership to form an active, committed Council who will work together to lead the Society forward from the 2014 AGM.

To assist with the demands of the Herd Registrar's role, Council decided to formally split the tasks between two members, creating Herd Registrar (HR) and Herd Registrar's Assistant (HR Assist) roles. This is working very well, thanks in large part to the two very able and conscientious members – Tony Houlbrooke (Herd Registrar) and Mary Howard (Herd Registrar's Assistant) – who agreed to step into these respective roles.

Many thanks go to Grant Keymer for supporting Tony and Mary during this changeover and for being available to provide on-going backup. The operation of the new Herd Registry has continued to run smoothly with the exception of a few 'out of the ordinary' scenarios.

I wish to thank Carol Ring for her work as Herd Registrar and to acknowledge her commitment to the role.

It is unfortunate that the Dispatch Editor, who took over the reins following Keith Wratt's resignation at the last AGM, felt that she was unable to continue in the role. After Angela Stevens' resignation as Editor, and much discussion by Council, Maureen Pettersson 'stepped up to the plate' and has produced three very creditable issues, managing to keep costs to a minimum. This has resulted in considerable savings for the Society. Well done, Maureen.

The changes I have outlined may have been perceived by some members as indicative of the beginning of the demise of the DCSNZ. This is far from true. The Society is in good shape – financially and technologically and it has had a committed group of office-holders, both on and off Council. This combination has seen every effort being made to carry the Society forward while keeping the best interests of the membership to the fore. I trust that this will continue with the newly elected Council.

I would like to thank Nancy Edge for working closely with Council since last November, in her co-opted role as Chairperson. Nancy's vast knowledge and expertise have assisted Council to gain clarity when dealing with several challenging issues over the past eight months.

To preserve the integrity of a Council elected by the membership, all current Council members have voluntarily stepped down and offered themselves for re-election at the 2014 AGM.

I would like to acknowledge the hard work and professionalism of Council members during what has, at times, been a challenging year. Each person has played a valuable part and brought his/her own special skills and attributes to the team. In addition to the members I have already mentioned, Grant Keymer has done an outstanding job as Treasurer and Webmaster. Garth Woodward has held a challenging, and at times, frustrating portfolio (Area Groups) as well as Promotions. His health has been his main concern over the past year but it's good to see that this has now improved. Special thanks must go to Robyn Snelgar for the enormous amount of time she has continued to devote to her secretarial duties this year and also to the time and energy she has put into organizing this year's AGM.

In addition to the HR and HR Assist, the Complaints Officers also hold positions off Council. I would like to thank both current Complaints Officers, Maggie Bentley and Dia Burgess, for their input over the past year.

A new role, endorsed by Council, has recently been confirmed – Brenda Batchelar has taken up the challenge of researching articles and items of interest for publication in the Dispatch. I look forward to some interesting reading in the future.

I trust that members will make an effort to attend the AGM and that those of you who do will find it an informative and enjoyable weekend.

Treasurer's Report 2013/14

On following pages you will find an audited copy of the society's accounts to 31/3/14, and the proposed budgets for the coming year to 31/3/15. Here is my analysis of the accounts for the year that has passed:

Membership Functions

Subscription Renewals for the year have worked out pretty much according to budget, which is a pleasing result.

New member signups have totalled about \$400 more than last year, and new herd/stud registrations have added almost a further \$200. Last year, we had a total of 372 financial members, including 5 life members. As at 31st March we had 352 financial/life members, which is a drop of 20, following on from the drop of 47 members during the previous year — a total decrease in membership of 67 over the past 2 years. In recent months, this trend has shown signs of reversing, and if that happens, we could reasonably expect to see a small increase in membership this year.

With membership renewals more-or-less according to budget, new member signups comfortably exceeding budget, and membership expenses below budget, the overall surplus from membership has exceeded budget by \$700 — a very pleasing result.

Due to a difference in timing of payments from last year, we have ended up paying for 5 Dispatch issues this year, instead of the normal 4. Consequently, the printing cost is about \$1300 above budget, but this will revert to normal next year. However, we have still saved almost \$2400 compared to last year, resulting from a change in the printing process used.

Cattle Functions

Income from Registrations, Transfers and DNA Profiling was pretty much according to budget for the year. Herd Registry expenses however, were well below budget, producing a surplus of about \$1100 more than anticipated. A great outcome considering that we have had a change of Herd Registrar during the year!

The Advertising budget for the National Open Day was hugely underspent! Only one Area Group spent all of their \$200 allocation, out of the 13 that were available. For next year, we have decided to let each Area Group organise promotional activities suited to their own requirements, and increase the funding cap to \$400 per year.

Area Group Support also came out well below the amount budgeted, although some of the funds available have been utilised recently with the BoP group sponsoring ribbons for 2 local A&P shows, the Waikato group sponsoring ribbons at the Morrinsville A&P show, and a small amount was used in the merchandise clearance auction.

The auction of surplus merchandise raised \$325, compared with the cost price of about \$1,300 i.e. a \$1,000 loss. This was unavoidable as the society had made some bad purchasing decisions in previous years, resulting in a stock of merchandise that nobody wanted, except at fire-sale prices. The remaining inventory will largely be given out to new members with their sign-up packs, or in the case of the Lapel Pins, most will be distributed to attendees at the upcoming AGM. A significant quantity of brochures is distributed at A&P shows each year, so these will be utilised over time.

Admin Functions

Interest income slightly exceeded budget, and expenses were lower than budget, so once again, we have a small increase from the budgeted surplus.

Council Travel Expenditure is well below budget because of the drastic reduction in council numbers. Whilst a large increase in workload has resulted for those of us who remain, we are now in a position to return to a full complement of councillors, with the funds available to pay for increased travel costs.

Expenditure on the AGM was reined in much more tightly last year, resulting in a saving of about \$1300 compared to the previous year's AGM in Wellington. Credit must go to Marion Mangnall for finding such cost-effective venues, and also to my initiative regarding a different method for printing the AGM booklet.

Summary

Overall the Society made a surplus of \$5,385 against a budgeted deficit of \$3,511 (refer to INCOME STATEMENT page).

On the BALANCE SHEET, Accumulated Funds total \$39,508 which is over \$5,000 more than in March last year.

We can continue using our surplus funds to cover any deficits for some years yet, and avoid increasing subs. The Auckland AGM will be considerably more expensive than last year's one in Lincoln, and we are looking at increased travel expenditure once we have more councillors on board. All things considered though, the society's finances continue to be in very good shape.

Budgets for 2013-14

I won't bore you with a blow-by-blow justification of each and every amount in the budget, but rather seek to highlight anything that is significantly different to the previous year:

Membership Functions

As a result of changing printing company and printing method for the Dispatch, we are expecting to save a further \$6,000 compared to last year. Postage is set to rise on 1st July, so we have purchased 2 years worth of stamps for the Dispatch, saving over \$500 during that time.

Cattle Functions

As mentioned earlier, we are not intending to run another National Open Day next year, hence the Advertising budget has been slashed. \$900 has been set aside for show ribbons, trophies etc, the same as it was last year. A quantity of promotional pens will have been purchased by the time you read this, so \$400 is budgeted for that. The funding cap for each Area Group has been increased to \$400, allowing for more flexibility in the type of events that could be covered. For example, a stand at an expo could now be paid for, whereas previously it was too expensive.

Admin Functions

An increased amount has been budgeted for Council Travel this year, in case we end up with more councillors. In the event that the budget remains unspent (as happened last year), the funds will be left in the savings account.

The net cost of this year's AGM to the society is expected to be approximately \$3700, or about \$2500 more than last year. This is largely a result of Auckland being a much more expensive venue than Lincoln. We could have chosen a conference centre well out of town, but travel costs from the airport would have mounted up for members flying in from around the country. The close proximity of Butterfly Creek to the airport, makes organising transport very simple.

Summary

This year's projected deficit is a modest one at \$1276. Based upon previous years, it is unlikely that all of the Area Group funding will be taken up, but we have provided for it nonetheless. The allowance for council travel is probably also on the generous side. My expectation therefore is a small surplus, in the \$3000 to \$5000 range. Keeping in mind that we still have 2 Term Deposits totalling \$14,500, and more than \$20,000 in the savings account, it should be possible to hold subscriptions at their current level for several more years.

Notes to the Financial Statements As at 31st March 2014

1 Statement of Accounting Policies

Reporting Entity

The Dexter Cattle Society New Zealand Incorporated is a Society formed and domiciled in New Zealand established under the Incorporated Societies Act 1908. The Financial Statements of Dexter Cattle Society New Zealand Incorporated are general purpose financial statements which have been prepared according to generally accepted accounting practice.

Measurement Basis

The accounting principles recognised as appropriate for the measurement and reporting of financial performance and financial position on a historical basis are followed by Dexter Cattle Society New Zealand Incorporated.

These financial statements have been prepared in accordance with generally accepted accounting practice in New Zealand. For this purpose the society has designated itself as profit-oriented. The information is presented in New Zealand Dollars.

Specific Accounting Policies

The following specific accounting policies which materially affect the measurement of financial performance and financial position have been applied:

- a *Revenue*
Interest is accounted for using the effective interest method, i.e. as it is earned.
- b *GST*
The financial statements are GST inclusive. Dexter Cattle Society New Zealand Incorporated is not registered for GST.
- c *Income Tax*
No provision for Income Tax has been made as there is no current or deferred tax payable.
- d *Inventories*
Inventories are recorded at cost.
- e *Investments*
Investments are carried at the lower of cost and net realisable value.
- f *Differential Reporting*
Dexter Cattle Society New Zealand Incorporated qualifies for differential reporting as it is not publicly accountable and it is small. Dexter Cattle Society New Zealand Incorporated has taken advantage of all available differential reporting exemptions.

Changes in Accounting Policies

There have been no changes in accounting policies from the previous financial year.

Membership Report 2013/14

As of the 1st April 2014 we have 347 financial Members and 5 Life Members, this being a total of **352**.

There were a total of **47 new members** in 2013/14, which is 3 less than 2012/13.

I thought perhaps we needed to think of encouraging prospective members to join now – rather than when they have bought their cattle or some join when they have their first calves on the ground. It has been decided to send all non-members who have had Dexters transferred into their names, a recent copy of the Dexter Dispatch and a Membership Application form, along with their Registration papers by the Herd Registrar.

We are down by 27 **from last year's membership** and resignations have gone up to 276, up 22 from last year. I would actually prefer members to give their resignations rather than members letting their membership lapse. We have had 3 members that have re-joined after resigning – 2 that wanted to sell their cattle within the Regulations of the DCSNZ, and another who changed their mind.

These members then have the option to apply for a full membership when they want to breed and register their own Dexters.

I look forward to meeting many of the members at the 2014 AGM in Auckland on the 7th June.

Showing and Judging Report 2012/13

Once again I would like to acknowledge the members who have shown their Dexters over the past season. Showing does involve work, but it can also be rewarding and a lot of fun.

A show does not just happen, however. Without the A&P Show organisers, judges, stewards and helpers on the day, the event would not run smoothly. I would like to thank everyone who supports and participates in showing Dexters. Judging by the amount of public interest in the Dexter ring and tie-up area at shows, it is a great way to promote the breed.

Due to family and work commitments some members who have exhibited their Dexters previously were unable to do so this season. However, there have been others joining the 'show circuit'.

Show results sent to me are forwarded to Grant for uploading to the website and to Maureen for publication in the Dispatch. The results on the website will create a historical record for future reference, so be sure to send them in if you wish to have them included.

The 2013/14 Royal Show was hosted by the Manawatu Consortium which had the contract for 2 seasons. The DCSNZ has been advised by the RAS Secretary that there will now be no Royal Show in 2014/15. Since the Dexter Society Royal Show Trophy will not be awarded, Council will recall the Trophy and hold it over until the following season. Hastings A&P has agreed to hold a Royal Event for beef cattle and sheep sections in 2014/15.

Paeroa and Waihi A&P Show Secretaries contacted me with an invitation to re-establish Dexter Sections at their shows in the past season. Both proved to be great venues and were well supported by members. The organisers of both shows would be delighted for Dexter members to continue to exhibit at their shows. I am hopeful that this will continue to be the case.

I received a message that Taumaranui A&P Society will also support Dexter entries at their show. Unfortunately there were insufficient members available in that area to show there last season. Maybe next year.....

The North Island Breed Show (NIBS) and South Island Breed Show (SIBS) were held at Rotorua and Gore respectively and were well-supported by members.

I encourage members to consider showing, particularly at the NIBS and SIBS, as these are the two annual Dexter Society Shows. All ribbons and the Supreme Champion Dexter Shields are provided by the DCSNZ. From the 2014/15 season, Council has agreed that all NIBS and SIBS ribbons will be ordered by the Society and sent to the respective host A&P Show Secretaries.

Council had previously stated that the NIBS would be offered to the Manawatu region after the Royal Show contract ended. Due to the changed circumstances regarding the Royal Show, I will make contact with the Feilding I, A&P Show Secretary, inviting them to host next season's NIBS.

The SIBS will be held in the Canterbury region in 2014/15, in line with the rotation decided by Council after discussion following last year's AGM. From feedback I received from some SI members, Canterbury does not appear to be a favoured venue for the SIBS. Both Oxford and Northern (Rangiora) A&P Show

Secretaries had expressed support for hosting the SIBS last year and may be open to hosting it next season. Venue TBC at the time of writing.

Positive comments continue to be made by both A&P Show personnel and the public with regard to the 'smart-looking' Dexter breed uniform worn by the majority of exhibitors.

The winners of the Snowline and Turoa Youth Trophies will once again be announced at the AGM and the Trophies presented.

Maureen and I have been asked by Council to represent the Dexter Society at the RAS Conference and AGM to be held in Wellington on 27-29 June. This promises to be a very informative weekend.

Area Group Report 2013/14

Perusal of the May issue of the Dexter Dispatch will reveal that there are still some vacancies in the nationwide coverage of Area Representatives, while those named are to be commended for their ongoing commitment to both local members and the Society at large. Herd Registrar's Report 2014

The new arrangement with Herd Registrar and Assistant Registrar has settled into a reasonably smooth arrangement since beginning early January 2014.

A few procedural issues have cropped up with registrations and transfers, though now rectified as noted:

1. The combination of a new registration and transfer at the same time. If the new registration is done online and the transfer sent in via post there is some delay getting the transfer and meanwhile the registration papers have been sent out. This means the green registration form has to be sent back. There is now a section to transfer at the same time as registration in the online registration area.

2. Date of birth of new registrations entered online. A few times people have not changed the default date entry to the actual date of birth – the default date is the date that they are entering the data. The date field has now been altered so an alert will pop up if the date is not entered.

Another important aspect of the Registrar's duties involves communication and most of this is via email. To date there have been over 150 emails sent or received. These are from and to members, GenomNZ (& Genemark) and Council members, especially Grant who has been hugely helpful in providing guidance, particularly with the non-standard things that seem to often rear their heads.

A recent suggestion has been taken up to send a copy of the Dexter Dispatch with membership application form to non-members who have animals transferred to them. This could give them information and encouragement to become members.

GenomNZ has recently offered to enter the Herd Book number of newly profiled bulls on to the profile certificate after the sire has been confirmed. This is helpful for both owners who wish to have this number on the certificate, and for the Registrar, as it is uncomplicated to include the HB number at this stage.

The task of the registrars I see as attempting to get accurate information back to members in good time. This has become further challenging with standard post letters taking as much as 5 days to arrive. Also from my personal perspective I wish to do this efficiently so that it is not consuming too much time.

The position (along with Mary's role) is to a large degree about trapping errors – not just from what members send in but also in what we do. They can sneak in all over the place – dates, signatures, names & spellings, misplacing of documents etc. I have this serious concern that one day I will be distracted and put wrong certificates in wrong envelopes and send them off!

Trusting that this is helpful in giving a brief overview for the 19 weeks that we have been dealing with the Registrar's position. Thanks to those who have been patient, gracious and courteous to me as I have settled in to this role.

Remits 2014

Remit 1 – Membership Fees

Proposed by Council

THAT membership fees remain the same for the next year.

Rationale: There is no need to make any change.

Remit 2 – Registration Fees

Proposed by Council

THAT registration fees remain the same for the next year.

Rationale: There is no need to make any change.

Remit 3 – Transfer Fees

Proposed by Council

THAT transfer fees remain the same for the next year.

Rationale: There is no need to make any change.

Remit 4 – AGM Correspondence

Proposed by Council

THAT all correspondence to be tabled at any AGM, must be received by the DCSNZ Secretary no later than 15th May and must be headed – Letter to be tabled at the forthcoming AGM.

Rationale: To provide clear instruction to the secretary of the purpose of such communication and allow the relevant parties time to prepare a response for the members at the AGM.

Remit 5 – Council Nominations

Proposed by Marion Corbett/seconded by Marion Mangnall

THAT the regulations be changed to read that members standing for council must be nominated by a DCSNZ member outside of council and familial relationships.

Rationale: This will encourage prospective councillors to seek wider membership participation.

Council right of reply to remit:

- If this remit were to be adopted it will contravene Clause 4.3 (a) of the regulations and could not become effective until Clause 4.3 (a) is also amended by remit at a future general meeting. Council has received legal advice that the Constitution would also need to be changed at considerable cost to the Society.

Remit 6 – Complaints

Proposed by Marion Corbett/seconded by Marion Mangnall

THAT Regulation 3, Misconduct of members – complaints procedure be added to as:

(j) Members may make their complaints directly to the Complaints Officers.

Rationale: There will be times when the complainant will be more comfortable dealing directly with the Complaints Officers.

Council right of reply to remit:

- If this remit were to be adopted it will contravene Clause 3(a), (d) & (g) of the regulations. Therefore it cannot be implemented until these regulations have been amended by remit at a future general meeting.
- Currently the Incorporated Societies act is under review at parliamentary level. This review will make provision for societies to specify their complaint process within their constitution.
- Council is currently reviewing DCSNZ Inc. complaints procedure and members will be invited to make submissions at a later date.

Remit 7 – Complaints Officers

Proposed by Marion Corbett/seconded by Marion Mangnall

THAT Complaints Officers are to be encouraged to investigate, ask questions of other members – anyone who may shed light on an issue.

Rationale: The Complaints Officers should be seen to act independently within the Dexter Cattle Society, with no interference or persuasion from any committee or sub-committee.

Council right of reply to remit:

- It is standard practice in any official enquiry to ask for statements from only those directly involved and witnesses (if any) to an event. Confidentiality must be preserved throughout the complaints process.
